
Comment may also be made by sending a fax to the District before 9:45 a.m. on October 26, 2022. The fax message will be read during the public comment period.

 - b. Receive Engineer's report on whether it would be feasible and practical to service the subject property if it is not in the Zapata Waterworks service area, and terms and conditions to provide service in addition to payment of annexation fee.
 - c. Receive and consider Petition for Annexation of the subject property if the subject property is not in the Zapata Waterworks service area (District can not service property not in the District).
