NOTICE OF DEADLINE TO FILE AN APPLICATION FOR A PLACE ON BALLOT (AVISO DE FECHA LIMITE PARA PRESENTAR SOLICITUDES PARA UN LUGAR EN LA BOLETA)

In accordance with the Texas Water Code and the Texas Election Code, Zapata County Water Control & Improvement District (Highway 16E) shall hold an election on May 2, 2026, in order that three (3) directors may be elected to membership on the Board of Directors of Zapata County Water Control & Improvement District (Highway 16E) to fill the place of three (3) directors now serving whose terms of office will expire on May 13, 2026.

The first day to file an application for place on the ballot is January 15, 2026. An application for place on Ballot must be filed not later than five o'clock (5:00) p.m. on February 13, 2026.
